A HISTORY LESSON

While sitting in five o'clock traffic on Winchester Road, bummed at the congestion, noise, and delays, you might want to think about the historic nature of the road you're on – and how the road back to Greenbrier has been used for centuries.

Before this area was settled by pioneers, Winchester Road, known as the Midland Trail, was a hunting trail used by Native Americans. As the Revolutionary War ended in 1785, this trail already formed the corridor of westward movement, as settlers, soldiers and travelers journeyed from Ashland across the Commonwealth through Morehead, Mt. Sterling, Winchester, Lexington, Frankfort and Louisville. The first stagecoach line in Kentucky, one of nine in the entire USA, started operating here in 1803 and ran for most of the 1800's. In 1835, Winchester Road was included in a network of turnpikes (toll roads) established throughout central Kentucky. Its completion in 1839 was celebrated in poetry, and though much used, the Winchester "Pike" was unpopular with travelers due to the tolls imposed. In 1882, our road was "macadamized" – the process of covering the roadbed with smallish stones to create a paved surface. This was unusual for the time and evidence of the significance of this route for early east-west travel. Dr. Thomas D. Clark, the late Kentucky Historian, said the famine in Ireland brought a wave of Irish immigrants to this area desperate for work. These men were used to build roads, including ours. The men used a round hammer with a hole in it called a "napping hammer" to beat the rocks. An inspector went around with a sized ring, and if the rocks he chose wouldn't go through the ring, they were too large and had to be broken up further. The crushed rock was mixed with sand and some lime and laid on the surface of the road to a depth of 9 or 10 inches.

By 1900, the turnpike and its tolls were eliminated in favor of designation as a free and public roadway, and between 1910 and 1919, the surface was laid in concrete, again testimony to its importance. In 1925, the federal highway system was established; a year later the route was designated US 60, a primary highway until Interstate 64 was created parallel and north of the road. What is now the Greenbrier golf course and subdivision was, according to Dr. Clark, a remount station, which supplied fresh horses and mules to the US Cavalry in the Spanish American War and WWI. Indeed, according to a 1921 issue of *Cavalry Journal*, the Army sought "high-class registered Thoroughbreds" to add to their breeding program, which explained the necessity of establishing a facility here. Historic homes, churches, and farms can still be found along this corridor, designated a State Scenic Highway several years ago, though pressure to develop threatens its unique character. Now, with more apartments, houses, and a school under construction, this historic road may possibly be facing its most drastic change yet – being widened so even more travelers can sit in five o'clock traffic, oblivious to what lies beneath their wheels.

From the Greenbrier Board of Directors

New Lighting for our Front is on the way!

The GRI Board has voted to improve the lighting at our front entrance. This was possible partially due to our improved Dues paying participation rate. Three reputable companies were quoted. **Innovative Landscape Lighting of Kentucky** has been contracted to provide a state-of-the-art, high efficiency, low voltage landscape lighting system.

The Winchester Entrance side walls will be evenly illuminated along with the associated 4 columns. This will create a backdrop to the existing landscaping and deliver a wide, warm inviting atmosphere to visitors and residents alike. It will also add a safety factor to the entrance by subtly defining the entrance and exit lanes. Each wall will have 2 accent fixtures up-lighting and highlighting the columns. Additionally, 5 mini wall wash fixtures will evenly illuminate the wall structures.

The contract includes the following features:

- Installation of new 12/2 wire as required. Wire to be buried against inside and outside walls and will be in direct burial electrical code protective flex hose.
- A Voltage control system that shall be adjusted to insure correct lamp operation, color and life.
- 4 Kichler accent fixtures with drop in, 6-year warranty, LED MR16 bulbs
- 10 VISTA, 10-year warranty, wide beam, LED integrated mini wall wash fixtures

Total Cost - \$2,296.00

Greenbrier Real Estate Snapshot

As of 11/29/2016 there are 11 single family homes and 1 town home on the market in Greenbrier. There is one currently under contract and 9 have sold and closed thus far in .2016. Looking at the averages for the neighborhood in 2016, it took 164 days to sell a home and the average sales price was 555,722. According to the US Census Bureau, there are 19,599 people under the age of 54 who live in 40509 while there are just 6,769 above the age of 54. Local trends likely would show that there are more individuals below the age of 54 who are looking to move to our area than those 55 and above. 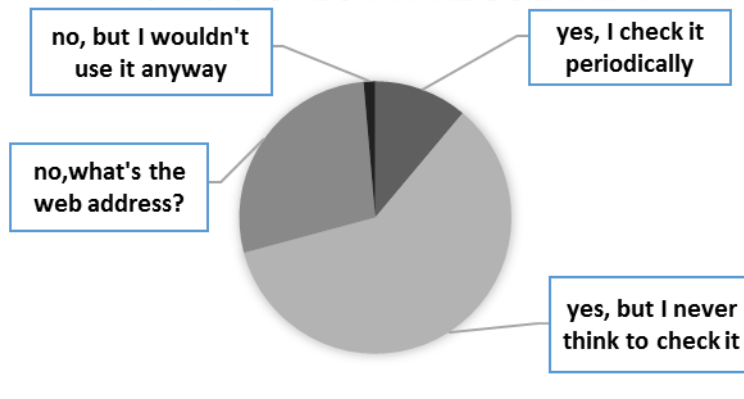

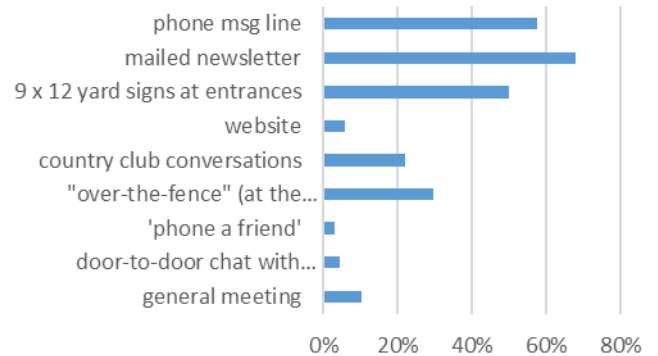
